





# Executive Summary & Overview



Metric	October	November	December	Trend
Reports/Events	49	39	39	<b>Stabilized:</b> Sharp decline from October followed by sustained lower activity in November and December.
Arrests	14	11	12	<b>Moderate fluctuation:</b> Arrests declined after October but showed a slight rebound in December.
Citations	8	2	2	<b>Sustained reduction:</b> Citation activity dropped sharply after October and remained consistently low.
CAD Events*	467	518	593	<b>Upward trend:</b> CAD activity increased steadily, reaching the highest level in December.

The overall activity transitioned from an October peak into a more stabilized operational pattern. Reports and arrests declined after October and remained relatively consistent through November and December. In contrast, CAD events showed an upward trajectory, indicating heightened calls for service and proactive activity despite lower reportable outcomes. ***Key Insight:*** While formal enforcement actions declined after October, rising CAD activity suggests continued operational demand and engagement within the transit system.

\*CAD event numbers presented in this report are limited by the RMS and may not capture all activity

# Location Analysis - Area of Focus



Location	October	November	December

CapMetro Property	12	17	14


- **Bus Stops:** Activity declined sharply from October to November, then partially rebounded in December, though remaining below October levels.
- **On Buses:** After a November decline, activity increased again in December.
- **CapMetro Property:** Activity peaked in November before decreasing slightly in December, remaining relatively stable overall.

## Overall:

October remained the peak month, November reflected a broad reduction, and December showed slight increases particularly at bus stops and on bus incidents.
